Excellence Recognition

At the Committee of the Whole Meeting on Wednesday, February 11, 2009, Superintendent Cox presented the following Excellence Recognition Awards.

Excellence in Social Studies

2008 State and National Champion Mock Trial Team is from **Jonesboro High School** in **Clayton County**. The Georgia Mock Trial Competition helps students gain an understanding of the legal system by providing opportunities for school teams to participate in academic competitions —where players assume the roles of attorneys and witnesses in a court case. Representing Jonesboro High today is Mock Trial Teacher **Mrs. Anna Cox**, students: **Jurod James, Jayda Hazell, Joe Strickland, Bridget Harris, Braeden Orr, Tabias Kelly, Brian Bady, Adrienne Marshall, Dominique Delgado**. **Honorable John C. Carbo** from the State Court of Clayton County, the **Honorable Deborah Benefield** from the Superior Court of Clayton County and **Ms. Tasha Mosley**, Solicitor-General of Clayton County were also in attendance.

<u>2008 Stock Market Game</u> - Oliver Elementary in Clayton County. Mike Harrell has been the advisor for the Georgia stock market game at Oliver for the last four games. This year, Oliver's team used a strategy of short selling housing-related financial institutions and mortgage providers that would suffer heavy losses in the current subprime mortgage crisis. During the 10 week game the team of two fifth grade girls turned their hypothetical \$100,000 into a portfolio value of \$263,521.

Georgia Council on Economic Education recognizes outstanding teachers based upon their knowledge of economics, use of effective instructional strategies, enthusiasm, and creativity.

Mrs. Joanna Errera, from Luella Elementary, was named the 2008 Georgia Economics

Teacher of the Year. Mrs. Errera is currently teaching 4th grade and was recognized as Georgia Economics Teacher of the Year because of her commitment to making economics education a vital component in elementary education.

<u>National History Day Contest</u> winner was **Ajori Spencer**. His teacher, Mrs. Renae Evans, accepted this award on Ajori's behalf. Ajori attends **Wheeler County High School**. Ajori is a senior at Wheeler County High School and is currently dually enrolled, taking a full load of college coursework at Brewton Parker College. For his winning project, Ajori created a ten-minute documentary outlining the struggles of Hispanic youth during the Chicano Movement of the 1960s.

Georgia Council for the Social Studies, "Best in Fair. Winners were Ally Holland and Kasey Wilson from Union Grove High School in Henry County Schools. Ally and Kasey are both sophomores on the honor roll who excel in Social Studies. When their church held a seminar on gang awareness in their community, they had an idea for a social studies fair topic- "Why Do Girls Choose to Join Gangs?" Their research involved interviewing the Henry County Criminal Apprehension Gang Enforcement Unit, collecting evidence of gang activity in Henry County and surveying elementary, middle and high school students about gangs.

<u>Georgia Council for the Social Studies 2008 Outstanding Educators Award</u>. This past October in Athens, three outstanding social studies educators were recognized during the annual conference.

The first winner of this award is **Mrs. Fran Bollinger**, a fourth grade teacher at **Sedalia Park Elementary**. Ms. Bollinger is a teacher leader, who models lifelong learning for her peers and students.

The next Georgia Council for the Social Studies 2008 Outstanding Educator Award goes to Dr. Laura E. Meyers. Ms. Meyers is an assistant professor in the area of elementary social studies in the College of Education at Georgia State University.

The last **2008 Outstanding Social Studies Educator Award** goes to **Mrs. Sue Funk**. She is a teacher at **Midland Middle School** in **Muscogee County**. Mrs. Funk has taught school for 28 years. She is presently a gifted lead teacher, teaching 6th, 7th and 8th grade students in a special resource class.

Next to be honored was the **Georgia Council for the Social Studies Program of Excellence Winner.** Luella Elementary in Henry County is the 2008 Winner and Dr. Lois Wolfe,
Luella's principal, will be accepting the award. The social studies program at Luella Elementary
implements curriculum integrating four strands of social studies where students actively
participate in learning. The program promotes reading across the curriculum.

The next award was given by the **Georgia Leadership Association for the Social Studies**. The **2008 Georgia Outstanding Supervisor Award** goes to **Dr. Cathy Geis**. Dr. Geis serves as the K-12 Social Studies and Foreign Language Coordinator for **Fayette County Schools**. Dr. Geis was also named the **2008 National Outstanding Social Studies Supervisor Award** by the **National Social Studies Supervisor Association**.

Two student delegates were selected to represent Georgia at the **47th Anniversary of the United States Senate Youth Program** in Washington, D.C., March 7-14, for a week of intensive study of the people and machinery of the American governing system.

Joseph Wells Ellenberg attends Frederica Academy, a private school in Glynn County. Joseph is the student body President, Business Manager and Editor-in-Chief of the school annual, Varsity Golf Team Captain, Executive Board member of Reaching Out, United Community Bank Junior Board of Directors, Glynn Co. Chamber of Commerce Leadership Glynn Program, and Boys State/Boys Nation.

The next student participating in the United States Senate Youth Program is **William McCormick Burgess**. William is a student at **Sequoyah High School** in **Cherokee County**. William, a resident of Woodstock, is the Student Body President at Sequoyah High School.

Guidance and Counseling

The School Counselor of the Year awards program was open to all 100,000 members of the school counseling profession. The top ten school counselors were nominated by their peers and administrators, and judged by a select panel to be the "best of the best." The candidates were judged on several criteria, including: creative school counseling innovations, effective counseling programs, leadership skills, and contributions to student advancement.

The winner for the American School Counselor Association "2009 National School Counselor of the Year" is Ms. Julie Hartline. Ms Hartline is a counselor at Campbell High School in Cobb County. Ms. Hartline was also named 2007 Cobb County High School Counselor of the Year.

The first honoree of the **2009 National School Counselor of the Year Finalist** from the American School Counselor Association is **Mr. Michael "Brian" Law**. Mr. Law is a counselor at **Valdosta High School** in Valdosta City Schools.

The next recipient of the **2009 National School Counselor of the Year Finalist** from the American School Counselor Association is **Mrs. Karen Gannon Griffith**. Mrs. Griffith is an Elementary School Counselor at **Berkeley Lake Elementary** in Gwinnett County.

The next three outstanding counselors received the state's highest honor for guidance counselors from the Georgia School Counselors Association. They are the <u>2008 Elementary</u>, <u>Middle</u>, <u>and Secondary Counselors of the Year</u>. Mrs. Griffith is also the <u>2008 Georgia Elementary School Counselor of the Year</u>.

The **2008** Georgia Middle School Counselor of the Year winner was Ms. Heather Roth. Ms. Roth has been a counselor at **Otwell Middle** for the last 5 years in **Forsyth County**. Ms. Roth is a Nationally Certified Counselor through the National Board of Certified Counselors (NBCC). She is a member of the American School Counselor Association.

Our **2008** Georgia Secondary School Counselor of the Year recipient is Dr. Helen M. Clark. Dr. Clark is a High School Counselor at Dacula High in Gwinnett County. Dr. Clark has been a School Counselor in Gwinnett County for 15 years.

The Georgia School Counselors Association **2008 Georgia Counselor Educator of the Year** is **Dr. Teddi Cunningham**. Dr. Cunningham has been a professor at Valdosta State University for the last 10 years.

Next to be recognized was **Dr. Crystal Giddings-Jackson**, winner of the **2008 Georgia Writer of the Year** award from the Georgia School Counselor Association. Dr. Giddings-Jackson works at **South Cobb High School** in **Cobb County**. The Georgia School Counselor Writer of the Year Award is given to a Georgia school counselor who has contributed to the professional writings and professional learning of Professional School Counselors in Georgia.

The winner of the Georgia School Counselor Association **2008 Georgia Counselor Supervisor of the Year** is **Dr. Betty "BJ" Thomas McBride**. She works for **Muscogee County** as Director of Guidance. The Supervisor of the Year award is based on several criteria including the initiation of developmental school counseling and guidance programs, and demonstration of leadership.

Next was the recipient of the **2008 Georgia School Social Worker of the Year** award from the **School Social Workers Association of Georgia**.

The winner, **Ms. Ida Hafford-Brown** has worked as a School Social Worker in **Cobb County Schools** since 1990. Ms. Brown has been an active member of School Social Workers Association of Georgia for the last 17 years and has held several offices.

Milken Awards

The Milken Family Foundation National Educator Awards program gives public recognition and financial rewards to elementary and secondary teachers and principals who are furthering excellence in education. By honoring outstanding educators the program strives to attract, develop, motivate and retain talented people to the challenge and adventure of teaching. Superintendent Cox, along with Jane Foley from Milken, presented the winners with a check for \$25,000 to spend as they please. These two winners will attend a conference with Milken Educators from around the country in Los Angeles in April.

Ms. Susan Grigg is one of the first 2008 Milken National Educator winner. She is the International Baccalaureate Primary Years Program Coordinator at Sawyer Road Elementary in Marietta City. Ms. Grigg served as a teacher for ten years, and was instrumental in helping open Sawyer Road Elementary and helped guide her school through the authorization process to become an International Baccalaureate School.

The next **2008 Milken National Educator** winner is **Ms. Andrea King**, a gifted and special needs teacher, who teaches at **Rock Chapel Elementary School** in Lithonia. Ms. King is an exemplary teacher who embodies the true spirit of transformation education. Working with both gifted and special needs students, she is an expert at differentiation.

<u>Faithful Service Award</u>. Ms. Melinda F. Scarborough, who works for the Department of Education in School Nutrition, received her 30 year Faithful Service Award

SUPERINTENDENT'S REPORT

- 1. Superintendent Cox introduced Mr. Kenny Moore, who is now the new Director of the Atlanta Area School for the Deaf. Mr. Moore replaces Dr. Cynthia Ashby who recently retired.
- 2. Ms. Clara J. Keith, Deputy Superintendent for Policy and External Affairs gave an update on Legislative Issues. She talked about several House and Senate Bills that have an impact on education policy and funding. Summary information will be e-mailed to the Board members on a regular basis and if Board members have any questions about the pending bills, they should contact Mr. Buck Hilliard.

Chair Barrs asked Mr. Brad Bryant, Mr. Al Hodge, Mr. Larry Winter, Mr. Brian Burdette and Mr. Jose Perez to participate in the Legislative Conference Calls to provide direct feedback to the department with regard to legislative issues.

Announcements

- 1. Chair Barrs gave a list of the Local Board Advisory Committee to the Board. This Advisory Committee is made up of one local board member from each of the 13 Districts. They will have their first meeting in March and at that meeting will develop meeting dates and agenda.
- 2. Chair Barrs also gave a list of the Local Board Standards Task Force to the Board. This Task Force will hold their first meeting at the end of February. They have a 90-day plan to come up with recommendations and it is anticipated the Board will receive a draft of local board standards for review in May. One of the sections of that standard will be ethics. These standards will be posted for 60 days, with a public hearing in June, and will come back to the State Board for adoption in July. Chair Barrs indicated that we have never had standards or an ethics policy for local boards that was adopted by the State Board of Education. This is about highlighting the best practices that elevate the services of local board members.
