1. **Teacher-Student Data Link (TSDL) Project Grant - The Center for Educational Leadership and Technology (CELT)** Authorized the State Superintendent of Schools to accept a grant from The Center for Educational Leadership and Technology (CELT) in the amount of \$300,000 and to enter into contracts with vendors to implement the terms and conditions of the grant award.
2. **FY11 Contract - Covendis Technologies - Contract Renewal** Authorized the State Superintendent of Schools to enter into a contract with Covendis Technologies at a cost not to exceed \$2,098,049.00 in State/Federal funds.
3. **Grant – FY11 21st Century Community Learning Center (21st CCLC) Grants - Continuation** Authorized the State Superintendent of Schools to award a grant to 84 21st CCLC programs at a cost not to exceed \$28,093,008 in Federal Funds for the continuation of non-school hour programs and to accept the voluntary withdrawals of five sub-grantees and the termination of two sub-grantees.
4. **Grant – Title I, Part D, Subpart 1 Formula Grant to State Agencies** Authorized the State Superintendent of Schools to award a grant to three state agencies at a cost not to exceed \$1,186,929 in Federal funds for Title I, Part D, Subpart 1.
5. **Grant - FY11 Education for Homeless Children and Youth Grants - Continuation** Authorized the State Superintendent of Schools to award a grant to 30 local educational

agencies (LEAs) at a cost not to exceed \$1,479,710 in Federal Funds for McKinney-Vento continuation grants for homeless children and youth.

6. **Grant – FY11 - Even Start Family Literacy Program Continuation Funding**  
Authorized the State Superintendent of Schools to award the Even Start Family Literacy Grant to the Department of Early Care and Learning for the purpose of sub-granting second-year awards to ten Even Start Family Literacy programs at a cost not to exceed \$332,267.00 in Federal funds.
7. **Grant – High Performance Principals – FY11** Authorized the State Superintendent of Schools to award a grant to local educational agencies that employ high performance principals at a cost not to exceed \$28,800.00 in state funds.
8. **FY11 Grant – Allocation to Title III Statewide Consortium for Limited English Proficient Students** Authorized the State Superintendent of Schools to award a grant to Southwest Georgia RESA at a cost not to exceed \$423,302.00 in Federal Funds (Title III and Title I-A) for the Statewide Title III Consortium of school districts with low-density ELL enrollments.
9. **FY11 Grant – Title III, Part A, English Language Acquisition State Grant**  
Authorized the State Superintendent of Schools to award a grant to local school districts at a cost not to exceed \$15,192,618.00 in Federal Funds to support identification, assessment, and service to Limited English Proficient (LEP) and Immigrant students.
10. **FY11 Contract – Work Sampling System for Preschool Special Education**  
Authorized the State Superintendent of Schools to enter into a contract with Pearson at a cost not to exceed \$85,000.00 in Federal Funds for Work Sampling System (WSS) licenses, training, and manuals.
11. **Contract Amendment – Writing Assessment Contract Amendment** Authorized the State Superintendent of Schools to amend the contract with the Board of Regents of the University System of Georgia to increase by \$15,211.00 for a new total contract not to exceed \$1,360,789.00 in State Funds for the inclusion of the Grade 3 Writing Assessment for the 2010-2011 school year.
12. **Georgia Performance Standards for Eighth Grade Science Research and High School Epidemiology Courses** Approved the Georgia Performance Standards for the eighth grade Science Research course and the high school Epidemiology course.
13. **Common Core Georgia Performance Standards for English Language Arts Advanced Composition** Approved the Common Core Georgia Performance Standards for high school English Language Arts Advanced Composition.
