

August 15	Letter of Intent to transition from Targeted (TA) to Schoolwide (SWP)
October 31	Completion reports for previous fiscal year due to DOE
October 1	Title I Budget due for review/approval
January 1	Typical 5 <sup>th</sup> month of school – Thus adjusted allocations in place for those charter schools that experience growth/expansion
February	Annual GCEL Conference (optional)
May 15	Last date to submit budget amendments
